

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to compu21safetytraining.com and Compu21 Institute Corp and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Compu21 Institute Corp include compu21safetytraining.com and Compu21. The Compu21 website is a Online Training site. By using the Compu21 website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Compu21 may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Users' picture

If you purchase Compu21's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Compu21 may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Compu21 collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Compu21 may also use your personally identifiable information to inform you of other products or

services available from Compu21 and its affiliates.

Sharing Information with Third Parties

Compu21 does not sell, rent or lease its customer lists to third parties.

Compu21 may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Compu21, and they are required to maintain the confidentiality of your information.

Compu21 may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Compu21 or the site; (b) protect and defend the rights or property of Compu21; and/or (c) act under exigent circumstances to protect the personal safety of users of Compu21, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Compu21. Use of Cookies

The Compu21 website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. - SSL Protocol

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;

- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
